### REQUEST FOR PROPOSAL (RFP)

Food Vendor for OVRTWN Corner Location: Overtown, Miami, Florida

Deadline for Submissions: September 15, 2025

#### **Overview**

OVRTWN Corner is an innovative new space in the heart of Historic Overtown, Miami, opening in 2025. OVRTWN Corner, set to become a cultural and economic anchor for the community, will feature a dynamic mix of food vendors, retail kiosks for local entrepreneurs, a café/bar, and a flexible area for cultural programming and community gatherings.

We are seeking proposals from qualified catering or food vendors to establish and manage a food stall within a new neighborhood gathering spot situated at 1117 NW 3<sup>rd</sup> Avenue. The OVRTWN Corner is a symbol of ongoing revitalization efforts and a space for shared community and cultural expression. The food stall will serve as a welcoming gathering spot for residents, visitors, and center participants — providing high-quality food and beverages while reflecting the cultural vibrancy and heritage of Overtown.

## **Project Goals**

- Provide high-quality, affordable, and culturally relevant menu offerings.
- Create a welcoming environment that encourages social interaction and community pride.
- Offer opportunities for local sourcing and small business collaboration.
- Operate in alignment with the mission and values of the community center.

## **Scope of Work**

The selected vendor will be responsible for:

- Food stall operations, including staffing, menu development, and customer service.
- Maintenance and cleanliness of the food stall area.
- Compliance with all applicable health, safety, and licensing requirements.
- Coordination with the center's event schedule and community programming.
- Offering menu items that appeal to a diverse audience and accommodate dietary needs.

#### **Eligibility**

- Proven experience operating a catering company, food stall, mobile food truck, or similar food service.
- Strong business plan demonstrating sustainability and community alignment.
- Commitment to hiring locally and contributing positively to Overtown's economy.
- Familiarity with Miami's food safety and business licensing requirements.

## **Facility & Amenities Provided**

- Designated food stall space of approximately 176 sq. ft. (or combined 352 for two adjacent spaces)
- Access to water, electricity, and basic infrastructure.
- Available seating area near food stall

# **Proposal Requirements**

Applicants must submit the following:

- 1. **Business Overview** history, mission, ownership, and key staff.
- 2. **Menu Concept** sample menu and pricing.
- 3. **Operations Plan** staffing, hours of operation, ordering, and customer service approach.

## **Timeline**

- RFP Release Date: August 13, 2024
- Submission Deadline: September 15, 2025
- Interviews: Rolling interviews until selection is complete
- Vendor Selection: Mid to end of September
- Food Stall Opening Target: November 2025


### **Submission Instructions**
